What were the Fund's costs for the last year?

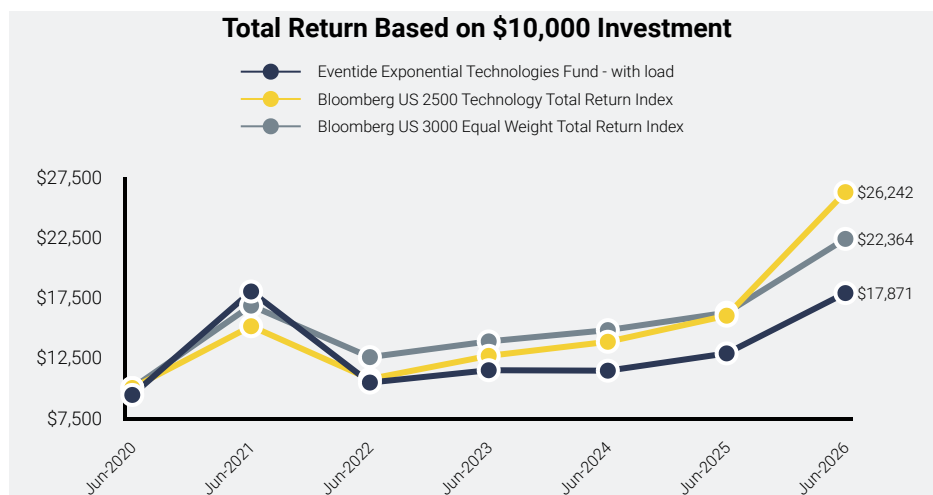

How did the Fund perform during the reporting period?

The Fund outperformed the benchmark during the period. This was due primarily to outperformance in the Industrial and IT sectors which overcame a slight drag from the Consumer Services and Financial sectors. The fiscal year exhibited many of the same trends that have persisted over the past two years, the most important being the size of the Artificial Intelligence ("AI") opportunity and outperformance of companies that help facilitate AI in realizing its potential. We also observed that small- and mid-cap began to stabilize and outperform compared to large and mega cap. We believe that a disciplined approach to positioning is well-suited to deliver long-term value across market cycles, while still enabling participation in themes of technological innovation driving human progress. How has the Fund performed since inception?



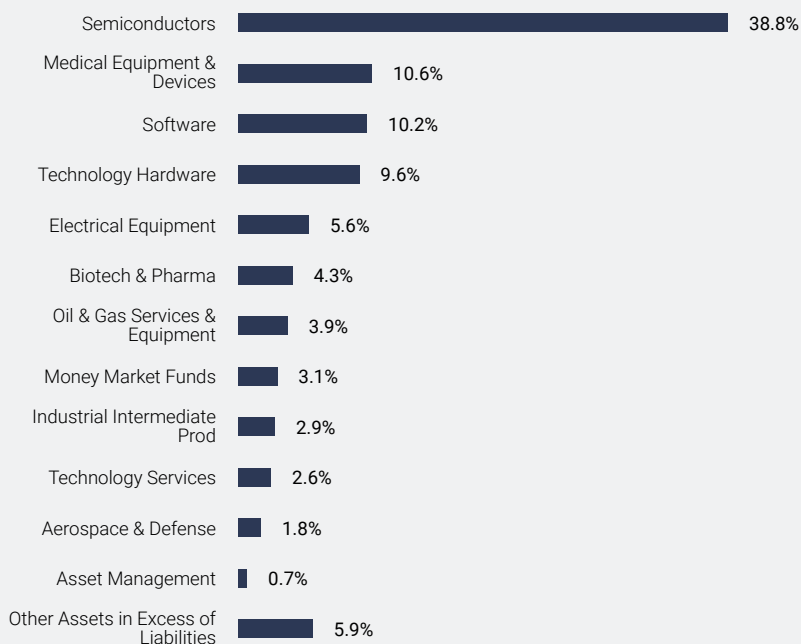

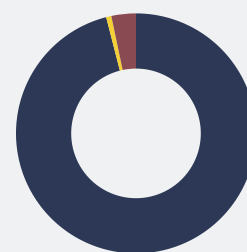
