What were the Fund's costs for the last year?

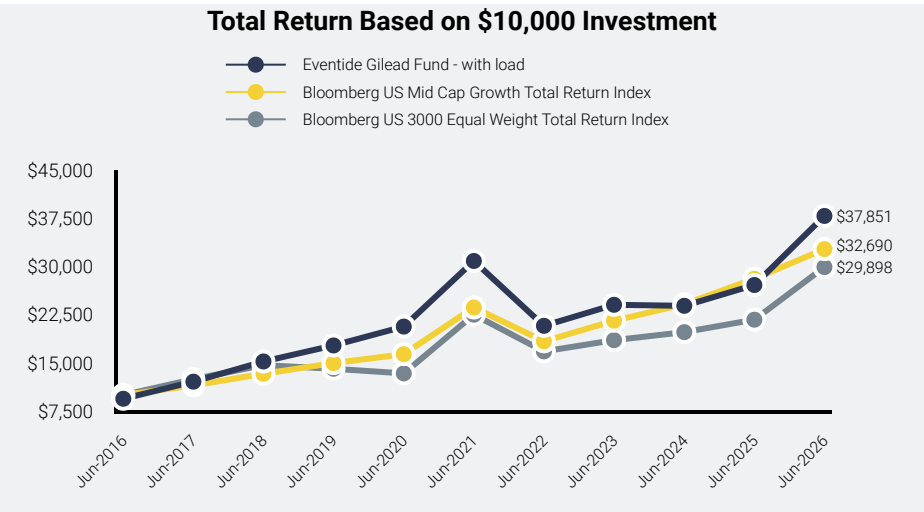

How did the Fund perform during the reporting period?

The Fund outperformed the benchmark during the fiscal year. This outperformance was due to both allocation and selection. Industrials exposure, favoring domestic manufacturing and global power, and Healthcare, with an overweight in biotech, generated the most sector outperformance. Financials and Communication Services, with significant underweights in the Fund relative to the benchmark, were the sectors that contributed the most to underperformance. The Fund's investment strategy remains anchored in the belief that companies with sustainable competitive advantages in attractive industries run by great management teams that focus on value creation for their stakeholders generate superior long-term risk-adjusted returns. How has the Fund performed over the last ten years?



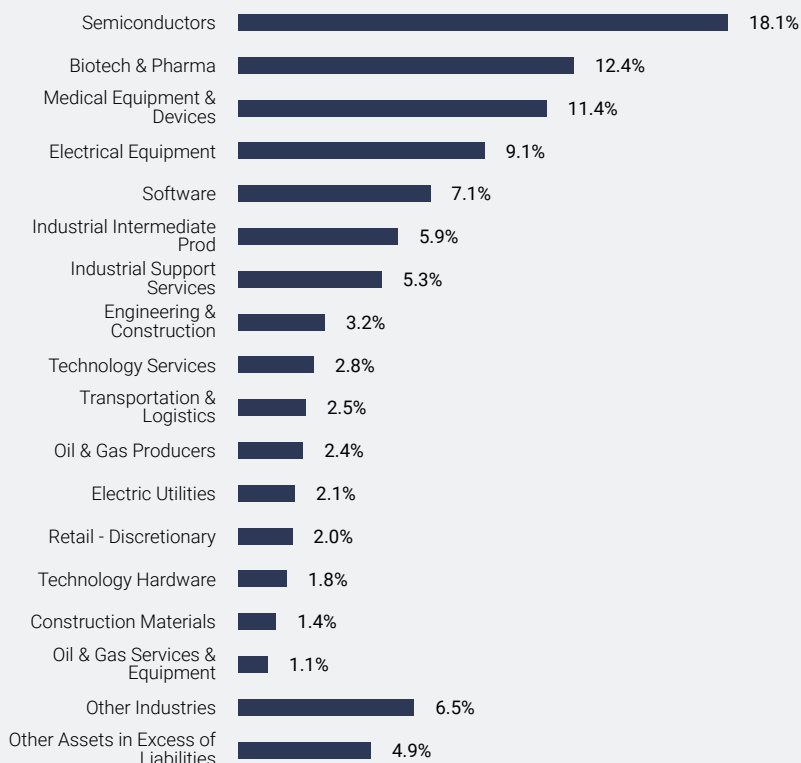

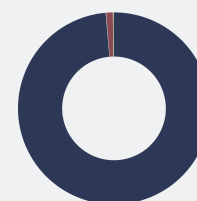
