What were the Fund's costs for the last year?

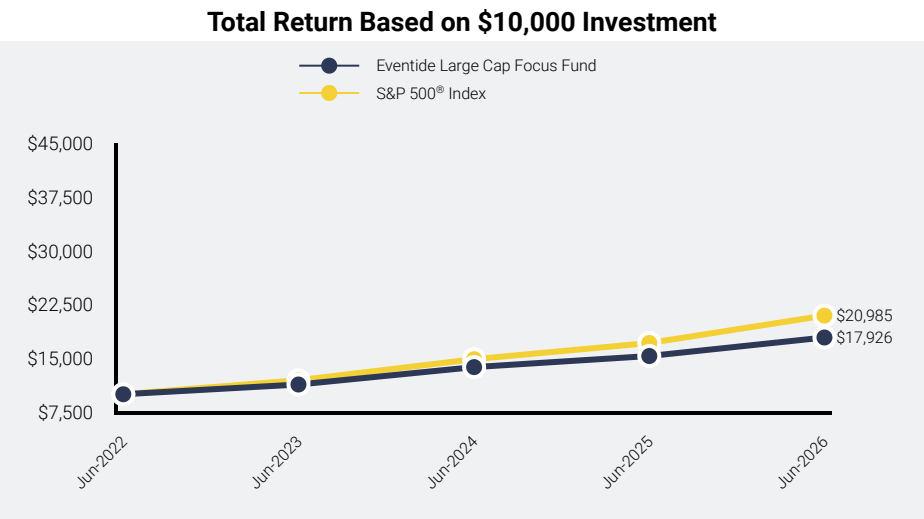

How did the Fund perform during the reporting period?

The Fund's underperformance in Financials, Materials, Utilities, Information Technology, and Healthcare was partly offset by outperformance in Industrials, Consumer Staples, and Real Estate. The Fund outperformed in the first half of calendar 2026 due to strong stock selection, particularly within Industrials and Information Technology. We remain focused on the Fund owning companies that create significant value for their stakeholders, while also trading at attractive valuations. How has the Fund performed since inception?



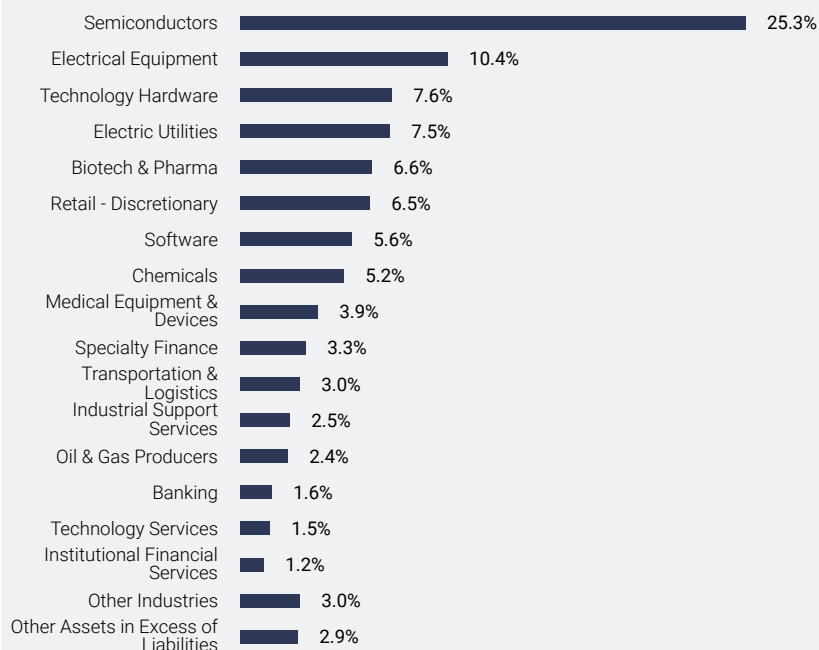

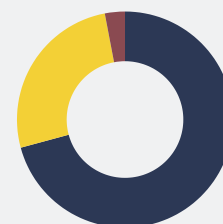
